

Millie's Mark Criteria

To achieve Millie's Mark, settings must:

- Complete the **training matrix**, including the staff confidence summary (template provided) and upload copies of all **Paediatric First Aid certificates**
- Complete the audit of practice (templateprovided)
- Complete the **risk assessment** (template provided) and upload a **floor plan** of the setting.

Awarding Millie's Mark will be dependent on all of the criteria below being met <u>in addition</u> to the legal requirements as set out in the National Minimum Standards for Regulated Childcare (NMS) and its associated regulations.

On receiving the Millie's Mark Award

- The provider will pay an administration fee to NDNA on application for Millie's Mark. The fee is non-refundable, even if NDNA deems that the criteria have not been met to its satisfaction. This is a one-off fee that covers the application and three year duration of Millie's Mark.
- A provider who has been awarded Millie's Mark will be permitted by NDNA to use the logo and display the Millie's Mark certificate confirming that the provider has been granted the award. The certificate includes the expiry date for using/renewing Millie's Mark.
- The provider will retain Millie's Mark for the duration of the three years, provided that no substantiated, evidenced concerns come to light to discredit the provider's commitment to PFA quality and coverage in the setting(s).
- NDNA may carry out'spot checks' in a sample of settings during the three year period to ensure that all criteria continue to be maintained.
- If an awarded setting receives two consecutive 'poor' ratings across all four inspection themes from Care Inspectorate Wales (CIW), regardless of the reason(s) for these ratings, NDNA will have the discretion to remove Millie's Mark from the setting belonging to that CIW registration.
- NDNA has an internal appeals and complaints procedures.
- The NDNA website lists all providers who have been awarded Millie's Mark.

Criteria Number 1

All childcare practitioners with direct care of children in a setting, including volunteers, MUST hold a paediatric first aid certificate that reflects the setting's risk assessment. This means that each childcare practitioner in a setting MUST have either:

• An up-to-date full PFA certificate (minimum 12 hours contact time); or

• An up-to-date emergency PFA certificate (minimum 6 hourscontact time).

In advance of training, the setting must complete an accurate paediatric first aid training 'needs assessment.' This will best indicate which of the two training qualifications are required. This could be a mixture of both qualifications across the workforce, depending on factors such as prior PFA experience, the number of children being cared for and the nature of any child's existing underlying health problems.

The provider will be responsible for determining which childcare practitioners have direct care of children and the type of PFA qualification they should hold, for example, considering staff other than early years practitioners who come into regular close contact with children at key times, such as lunchtime supervisors, drivers, escorts at ALN settings, etc.

NB: NDNA encourages providers to 'needs assess' their staff PFA training requirements via the templaterisk assessment document provided BUT it is the provider's responsibility to choose the most appropriate course.

The provider must submit evidence based on their risk assessment.

All childcare practitioners/childminders MUST holdanappropriate in-date PFA (full or emergency) certificate.



Criteria Number 2

Course content of the full (2 day, 12 hour) PFA training course must meet the existing requirements set out in the NMS. As a minimum, the content of the six hour Emergency PFA training must cover the elements prescribed in the NMS (Annex B).

The provider will ensure that all six hour Emergency PFA training attended by childcare practitioners is classroom-based and led by an appropriately trained PFA instructor.

The instructor should be able to assess the childcare practitioners /childminders' understanding of theory and practical techniques competently and they should demonstrate (using a manikin where appropriate) the correct first aid techniques required to the instructor's satisfaction. Assessment will result in an unambiguous Pass or Fail.

Whenever possible, the 12 hour PFA training will be undertaken face-to-face. Where this is not possible, the two-day PFA training course may take place as a combination of proportionate 'blended' online/practical provision. Ideally, the 12 hour training will take place on consecutive days. If this is not possible, the period between both days must be within six weeks.

Blended training is only permitted when any online element takes place on day 1, so that the trainer can check ability and challenge breadth of understanding (theory assessment and practical assessment) on day 2 prior to awarding a Pass or Fail assessment, with appropriate feedback to the childcare practitioner / childminder and their employer.

The provider must produce, on demand, evidence proving which course was attended and the qualification each childcare practitioner / childminder has achieved.

Receiving Millie's Mark indicates strong delivery of PFA training and PFA understanding. NDNA has the discretion to decline award of Millie's Mark if evidence supporting the expected standard is not submitted.

Providers should choose paediatric first aid training from one of the following organisations in order for it to be eligible for Millie's Mark:

- Ofqual, SQA or qualifications regulated by Qualifications Wales
- A Voluntary Aid Society
- A training provider who operates under a voluntary approval scheme, or one that is a member of a trade body with an approval and monitoring scheme, or
- A training provider who operates independently of any such accreditation scheme.

In order to reduce burdens on the sector, retain proportionality of effort and be realistic about the challenges of staff recruitment and staff turnover, providers will be given a <u>three month</u> grace period in which to upskill new staff/renew existing childcare practitioners PFA training. Providers will be permitted to retain Millie's Mark if action is taken within this time period.

Criteria Number 3

The provider must submit electronic certification and/or any other requested supporting evidence as confirmation that all early years practitioners have met all the criteria as agreed and developed by NDNA.
